This letter is to inform you of the wage and fringe benefit rate allocation per the Collective Bargaining Agreement negotiated by the Chicago Regional Council of Carpenters in full force and effect from June 1, 2019 through May 31, 2022. The following schedules summarize the negotiated increases for June 1, 2021 through May 31, 2022 for the following Illinois county of DeKalb and the portion of Ogle County defined by the following boundaries: IL Route 72, Meridian Road and the Southern Ogle County line; and the portion of Lee County defined as east of Brooklyn Road.
